

#### AGREEMENT STATEMENT

I agree to abide by the game rules and competition regulations of Pro Futsal. By signing the player or the team registration form I am in agreement that I am entering into a binding contract for the entire duration of the season and agree that competition management has absolute authority regarding decisions effecting the administration and conduct of the Pro Futsal competitions. I agree to be solely responsible for all nominations; and related fees payable for the season for the club/team. I understand that each player needs to be registered in order to play in any competition organised by Pro Futsal. understand the competition has a zero tolerance policy and a members' code of conduct to which I agree to comply as stated in competition regulations on this web site.

## **REGISTRATION FEE AND DURATION**

Registration fee is \$50 (AUD) and is valid until the 1<sup>st</sup> of January 2019.

In order to play in any competition organised by Pro Futsal registration must be renewed after the 2<sup>st</sup> of January 2019. Unregistered players are not allowed to play in any competition hosted by Pro Futsal. Pro Futsal reserves the right to accept or decline any registration at any time during the competition year. Registration will not be accepted without full payment of the required fees prior to the commencement of the first game. The registration fee is not refundable.

## **PRO FUTSAL PRIVACY POLICY**

Pro Futsal recognises that privacy is important and that individuals have a right to control their personal information. Pro Futsal acknowledges that providing personal information is an act of trust and Pro Futsal management takes this seriously. Unless an individual gives Pro Futsal consent to act otherwise, the following policy governs how Pro Futsal handles personal information of individuals.

#### HOW WE AT PRO FUTSAL ASSOCIATION COLLECT INFORMATION

Pro Futsal will not collect personal information unless that information is necessary for one or more of its functions or activities. Pro Futsal will only collect personal information by lawful and fair means and not in an unreasonably intrusive manner. Pro Futsal will only collect personal information by way of player registration form and/or insurance form. Personal information for 'non-members' who register for our competitions and events will be collected through registration or enrolment forms. Pro Futsal will also collect personal information over the internet.

# WHAT PERSONAL INFORMATION DOES PRO FUTSAL COLLECT?

The only type of personal information Pro Futsal may collect from you generally comprises name, address, age, gender, contact details (including phone, fax and email) and information, collected primarily for the following purposes, in the course of our business

 Personal information of participants in competitions played under our auspices, to effectively operate such competitions and for insurance purposes;

- Personal information of our coaches and referees, to effectively operate the competitions referred to and for insurance purposes;
- Personal information of participants in our various events, courses and competitions to contact in the event of an emergency;
- As explained below, the reason we collect this information is so that we can provide you with our touch information and updates, manage our relationship with you, communicate with you effectively and identify which of our services will best meet your requirements.

## HOW IS PERSONAL INFORMATION USED?

The personal information collected from you by Pro Futsal is used to: provide you with our touch information, updates and marketing campaigns. This will include use of personal information for establishing and maintaining your membership record (if relevant), or to enrol you in one of our courses, events or competitions; and/or notify you about services and promotions offered by us and our sponsors (whether you are one of our members, or someone who attends our courses, events or competitions, or someone else we have identified as possibly interested in our services).

Information provided will be used in various methods of communication namely but not limited too: direct mail, email, SMS, phone contact.

Pro Futsal will only use the personal information we collect and store for the purposes we have either advised or for which we have obtained consent.

As a sporting body, Pro Futsal needs to enter into sponsorship arrangements with third parties from time to time. One of Pro Futsal's objectives in doing so is to keep membership fees at a low level. This will sometimes mean that Pro Futsal uses personal information about you to provide you with information about products, services and promotions offered by our sponsors. If at any time you do not wish to be notified about the products, services or promotions offered by our sponsors, please let us know. Pro Futsal DOES NOT and WILL NOT provide personal information directly to sponsors.

#### WILL PERSONAL INFORMATION BE GIVEN TO ANYONE ELSE?

In the circumstances described below, personal information may be disclosed outside Pro Futsal:

- Insurance Personal information collected by Pro Futsal will be provided to the insurer when required.
- Pro Futsal DOES NOT sell, rent or trade personal information to or with third parties.

# ACCESS AND CORRECTION

Under the Privacy Act, you have a right to seek access to information which Pro Futsal holds about you (although there are some exceptions to this). ### IS PERSONAL INFORMATION STORED SAFELY?

Pro Futsal takes steps to ensure the security of personal information held by it from such risks as loss or unauthorised access, destruction, use, modification or disclosure. Pro Futsal only permits your details to be accessed by authorised personnel, and it is a condition of Pro Futsal committee to maintain the confidentiality of all personal information.

## **ONLINE PRIVACY ISSUES**

Pro Futsal will apply this policy to all personal information it handles, whether collected online or otherwise. To the extent that this policy applies to online privacy issues, it is to be read as forming part of the terms of use for our website. This clause is intended to provide more information about privacy for the users of our website.

Online collection of personal and non-personal information - Pro Futsal will not normally collect personal information through its website. However, our website collects other information which may or may not be personal information. For each visitor to our website, our server automatically recognises and stores your "address" (e.g. your domain name or Internet protocol address), the type of your Internet browser, and the address of the site which "referred" you to our website and click stream data.

In addition, our website may use cookies to track usage of our web site. Most web browsers are set by default to collect cookies. However, if you do not wish any cookies to be collected you may change the option in your browser.. Please note that rejecting cookies may mean that not all the functions on the website are available to you. We use cookies for tracking the statistics of our website. This allows us to better understand our users and improve the layout and functionality of our website. This tracking is conducted in such a way to ensure the anonymity of visitors – in this context the cookie may identify your computer – but it should not identify you.
